



Ganfeng lithium solar container project investment

The Mariana plant, in the province of Salta, represents a \$790 million investment and has the capacity to produce 20,000 metric tons of lithium chloride per year from extraction at the Llullaillaco salt flat. Ganfeng also spent \$190 million to build a solar park to support the plant's energy needs.
