When importing your products into Myanmar, the applicable national requirements must be fulfilled. We will be glad to advise you on the current regulatory situation, and to inform you about necessary further steps for the successful market access of your product in Myanmar.

<div class="df\_qntext">Do radio products need type approval in Myanmar?

We regularly review the necessity of type approval of radio products in the Republic of the Union of Myanmar, formerly known as Burma, in cooperation with the Ministry of Transport and Communications located in Naypyidaw. The homologation process in Myanmar does neither require local conformity testing, nor contact with local representatives.

<div class="df\_qntext">Who is responsible for sanitary and Phytosanitary Measures in Myanmar?

Department of Agriculture, Livestock Breeding and Veterinary Department, Department of Fishery and Food and Drug Administration Department are responsible for sanitary and phytosanitary (SPS) measures in Myanmar. SPS standards adopted by Myanmar follow those of CODEX, ASEAN, and the OIE.

Export and Import licenses can be applied through automatic licensing and non-automatic licensing systems on Myanmar Tradenet 2.0 platform.

It needs import licences for all kind of goods to import into Myanmar. The notification and announcements that are subject for Automatic Licensing and Non-Automatic Licensing systems are provided at the following links;
