<div class="df\_qntext">What are the regulations for solar panels?

The regulation requires you to correctly label your product, packaging, or accompanying documents, such as the instruction manual. You should provide product-specific warnings with your product. Note that some warning requirements may come from certain standards. This section lists several examples of standards for solar panels.

<div class="df\_qntext">Does the general product safety regulation cover solar & photovoltaic systems?

It does not cover the entire solar or photovoltaic system, which may contain components such as frames, battery packs, and inverters. The General Product Safety Regulation sets safety requirements for consumer products.

<div class="df\_qntext">What does the new EU solar law mean for buildings?

The new law is set to require solar installations on buildings across the European Union. This means that solar installations must be integrated into building works, and public bodies must retroactively install PV on their buildings, entering into force gradually from 2026.

<div class="df\_qntext">When will solar panels be required?

For existing schools, administration buildings, hospitals, etc., the requirement to install solar panels (where suitable and feasible) will apply gradually, starting with the largest public buildings (above 2000 m<sup>2</sup>) from 1 January 2028 and buildings above 750 m<sup>2</sup> from 1 January 2029.

<div class="df\_qntext">Are all buildings required to have solar energy installations?

However, not all individual buildings in these categories will be required to be equipped with solar energy installations: EU countries will set national criteria for the practical implementation of the requirement, notably related to the suitability of specific buildings for solar energy installations.
