By 2050, under the worst-case "hot" climate projection scenario, Mozambique's poverty level will increase by 5%, pushing 1.6 million additional people into poverty. If no significant structural transformation takes place, inequality, as measured by the Gini coefficient, will hardly change by 2050 under all the climate scenarios analyzed.
