A solar site survey report should capture all required details from the customer's sidefor creating a techno-commercial proposal.

A report should be automatically generated as soon as the solar site survey is completed,to minimize the time taken between site survey and proposal submission. This is very important in order to keep the competitors from stealing your prospects.

Site survey report format Main objective of a site survey is to gather customer details, site measurements and detailed requirements for solar installation project. All these details are very important for the solar project proposal. A solar project site survey should answer following questions - Is there enough space for solar PV installation?
