The Safety Law regulates the manufacture and sale of electrical and electronic products to prevent potential hazards. To prove conformity to mandatory technical requirements, the import and sale of Category A electrical and electronic products requires PSE certification through a Registered Conformity Assessment Body.

<div class="df\_qntext">Are non-specified electrical products eligible for PSE certification?

Non-Specified Electrical Products are not required to obtain third-party conformity assessment and are not eligible for PSE Certification, but can obtain voluntary S-JQA certification. Aquarium aerators (e.g. bubblers, air stones, etc...)

<div class="df\_qntext">Do importers need a PSE certificate?

However, the importer must obtain an official duplicate of the PSE Certificate from JQA at the time of import. Manufacturers or importers are obligated to test all models (both Specified and Non-Specified Electrical Products) for compliance with PSE technical standards and keep a record.

<div class="df\_qntext">Does JQA offer PSE certification services?

All Specified Electrical Products must undergo third-party conformity assessment for PSE certification and display the diamond PSE mark. JQA's PSE Certification services include: Conformity assessment and factory inspections are conducted for each factory location. Overseas manufacturers are eligible to be certificate holders.
