<div class="df_qntext">What's new in China's Export VAT refund policy?

The Chinese government has introduced significant changes to its export VAT refund policies (Value Added Tax rebates), effective December 1, 2024. These adjustments target various product categories and aim to encourage domestic consumption while reducing reliance on exports. If playback doesn't begin shortly, try restarting your device.

<div class="df_qntext">Does China have a tax rebate for solar panels?

Image: Bruno Corpet, Wikimedia Commons China's Ministry of Finance and State Taxation Administration have announced a reduction in the export tax rebate for photovoltaic products. Starting Dec. 1, the rebate for unassembled solar cells (HS Code 85414200) and assembled PV modules (HS Code 85414300) will drop from 13% to 9%.

<div class="df_qntext">What are the regulations for solar panels?

The regulation requires you to correctly label your product, packaging, or accompanying documents, such as the instruction manual. You should provide product-specific warnings with your product. Note that some warning requirements may come from certain standards. This section lists several examples of standards for solar panels.

<div class="df_qntext">Does the general product safety regulation cover solar & photovoltaic systems?

It does not cover the entire solar or photovoltaic system, which may contain components such as frames, battery packs, and inverters. The General Product Safety Regulation sets safety requirements for consumer products.

<div class="df_qntext">What are the changes to export tax refund filing documents?

The first, is the active implementation of electronic export tax refund filing documents and the second, is the new administration measures of foreign exchange collection. Effective from May 1, 2022, there are several changes to the record-filing documentation required for export tax refund. The main changes are summarized below:

<div class="df_qntext">How has China improved the export tax refund policy?

China has improved the export tax refund policy and traders should note the changes in documentation requirements and penalties for violation. The improvements to the tax refund process are facilitating electronic filing of export tax refund documents and new administration measures to optimize foreign exchange management.
