How does the government promote solar energy sustainability?

Subsidies and schemes for solar panels. The government promotes sustainability through tax benefits, as well as subsidies and schemes. There are various grants and subsidies available for the purchase of solar panels and generation of solar energy.

Do you pay VAT on solar panels?

Then you do not pay VAT (in Dutch) for the solar panels, parts, and installation. You use part of the electricity generated by your solar panels yourself. What remains, you feed back to the electricity grid. If you feed more back than you use, you will receive compensation from your energy supplier.

What tax schemes are available in Vamil?

You may be able to benefit from 2 tax schemes: the Environmental investment allowance (Milieu-investeringsaftrek, MIA) and/or the Random depreciation of environmental investments scheme (Willekeurige afschrijving voor milieu-investeringen, Vamil). What are the MIA and Vamil?

How much do solar panels cost in the Netherlands?

Although solar panels have become increasingly affordable (in Dutch) in recent years, purchasing them can be a substantial investment. A set of 10 panels will set you back an average of EUR5,400 (in Dutch), including installation and VAT. The Dutch government intends to cancel VAT on solar panels from 1 January 2023.

Will installing solar panels affect my commercial building insurance?

Installing solar panels can potentially affect the insurance for your commercial building. Many insurers also set certain requirements for the installation and maintenance of your solar panels. The amount of your premiums could also be adjusted, as the solar panels will increase the value of your buildings.

How many Dutch homes have solar panels?

Approximately 1.5 million Dutch homes (in Dutch) are equipped with solar panels, while a growing number of business owners are also installing rooftop solar panels. Statistics Netherlands (in Dutch) reports that for the first time in 2020, more solar panels in the Netherlands were found at businesses than at private homes.
