

What is the tax rate for solar container leasing services

<div class="df_qntext">Do you pay VAT on solar panels?

Then you do not pay VAT (in Dutch) for the solar panels, parts, and installation. You use part of the electricity generated by your solar panels yourself. What remains, you feed back to the electricity grid. If you feed more back than you use, you will receive compensation from your energy supplier.

<div class="df_qntext">Do I have to pay VAT on a leased business asset?

If you enter into a financial leasing contract, you will be charged VAT on delivery of the leased business asset. The VAT you paid is deductible as a preliminary tax. This does require that your business provides services eligible for VAT. No VAT is charged on your lease payment instalments. Operational lease means that you rent the asset.

<div class="df_qntext">Is VAT deductible on a lease payment instalment?

The VAT you paid is deductible as a preliminary tax. This does require that your business provides services eligible for VAT. No VAT is charged on your lease payment instalments. Operational lease means that you rent the asset. You periodically pay a lease amount to the lease company. With an operational lease, you are not the owner of the asset.

<div class="df_qntext">Where is a service taxed?

There are special rules that determine where the service is provided. These rules apply in all EU countries. If you provide services to entrepreneurs, the service is often taxed in the country of your customer. This means that the customer declares the VAT in his own country. In that case, you reverse-charge the VAT to this entrepreneur.

<div class="df_qntext">What is a zero VAT rate?

This rate is applied, among other things, to the export or intra-Community supplies of goods. The zero rate makes compliance significantly simpler and provides cash flow benefits for international trade. Moreover, it is very important to apply the zero VAT rate correctly. After all, wrongly applying the rate entails a material business risk.
